

The Yellow Glasses Project Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. How to Enter. **To enter The Yellow Glasses Project Giveaway (“Sweepstakes”) during the Sweepstakes Period (defined below)**, on Instagram, visit Sponsor’s Instagram page ([@theyellowglassesproject](https://www.instagram.com/theyellowglassesproject)) (“Instagram Page”), follow the Sweepstakes sponsor’s page, like the Sweepstakes post, and tag two friends in a comment on the Sweepstakes post. All entrants must have a valid email address. All information provided by entrants is subject to verification.

All entries must comply with any and all Instagram terms, guidelines and policies. This Sweepstakes is not sponsored, endorsed or administered by Instagram. All information submitted by entrants in connection with this Sweepstakes is being submitted to Sponsor, not Instagram. To the extent of any conflict between these Official Rules and Instagram terms, guidelines or policies, these Official Rules will apply.

All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor. No facsimile, mechanically reproduced, altered or forged entries.

2. Agreement to Official Terms and Conditions: By participating in this Sweepstakes, entrants agree to abide by these Official Rules. Any entrant who violates these Official Rules is subject to disqualification at any time at Sponsor’s sole discretion.

3. Start/End Dates. Sweepstakes begins at 9:00AM Eastern Daylight Time (“EDT”) on August 5, 2022 and ends at 12:59AM EDT on August 6 2022 (“Sweepstakes Period”). After the Sweepstakes Period, no entries will be accepted or deemed eligible to win. Sweepstakes will also be on August 19 and September 2.

4. Eligibility. Participation is open only to legal residents of the United States of America who are eighteen (18) years of age or older as of the date of entry. Entrants are subject to all federal, state and local laws, rules and regulations. Void outside of the areas specified herein and where prohibited, taxed or restricted by law. The following are not eligible to enter the Sweepstakes: employees, officers and directors of Sponsor and its parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, any agencies involved with administering the Sweepstakes, manufacturers or distributors of Sweepstakes materials (the “Sweepstakes Parties”) and the immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of the Sweepstakes Parties.

5. Random Drawing/Odds. Two (2) winner(s) will be selected by Sponsor in a random drawing from all eligible entries received to be held on or about July 22, 2021. The odds

of winning depend on the number of completed, eligible entries received for the drawing. Sponsor is responsible for determining the winner of the Prize in its sole discretion, subject to these Official Rules. - Two(2) sticker sheets

Approximate value of prize is \$37.55 USD. The kit will be sent via postal mail at the time of prize acceptance. Actual/appraised value may differ at time of prize award. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of each winner. Acceptance of prize constitutes permission for Sponsor to use winner’s name, likeness, and entry for purposes of advertising and commercial purposes without further compensation, unless prohibited by law. No substitution of prize or request for the cash equivalent by winner is permitted except in Sponsor’s sole discretion.

7. Notification. The winner(s) will be notified by Direct Message from the giveaway post on or about **the following week of the giveaway**, and may be required to sign and return, where legally permitted, an Affidavit of Eligibility and Liability/Publicity Release (“Affidavit”) within five (5) days of Prize notification. If the winner cannot be contacted within five (5) calendar days of Prize notification attempt, if any Prize or Prize notification is returned as undeliverable, if the winner rejects a Prize or fails to comply with these Official Rules, such Prize will be forfeited and an alternate winner will be selected from all remaining eligible entries. Upon Prize forfeiture, no compensation will be given. Limit one (1) Prize per person or household.
